TERMS & CONDITIONS:

Children from class 1 to 10 will be eligible to participate in this competition. They will be categorized as follows: (class 1 – 3) Sub Juniors, (class 4 – 6) Juniors, (class 7 – 10) Senior group.

Selected children from the preliminary round will compete at the GRAND FINALE.

The preliminary round of the chess competition will be held at the respective school premises and toppers from each class will qualify for the final round (inter-school competition) to be held at a pre-decided venue.

Each player will play for five minutes each set on each player's clock. Time delay features are not entertained. This is a lightning league chess tournament and shall be played in a Swiss –league format.

Organizers will provide the chess clock, chess board and pawns.

Each participant should pay a sum of Rs. 300/- as registration fee for taking part in the competition which is a one time fee.

Participation certificate will be provided to every participant.

TOP 3 BEST CHESS PLAYERS UNDER SUB-JUNIOR, JUNIOR & SENIOR GROUP WILL BE AWARDED AS FOLLOWS:

ONE 1st PRIZE WINNER WILL GET A GIFT CHEQUE WORTH RS. 2000/- ALONG WITH A TROPHY & CERTIFICATE

ONE 2nd PRIZE WINNER WILL GET A GIFT CHEQUE WORTH RS. 1000/- ALONG WITH A TROPHY & CERTIFICATE

ONE 3rd PRIZE WINNER WILL GET A GIFT CHEQUE WORTH RS. 500/- ALONG WITH A TROPHY & CERTIFICATE

12 CONSOLATION PRIZES IN EACH CATEGORY WILL BE AWARDED WITH A TROPHY & A CERTIFICATE
